## The Draft Lockyer Valley Planning Scheme has been developed by Lockyer Valley Regional Council in accordance with the *Planning Act 2016*.

During the consultation period, any person may make a submission on any element or matter of the Draft Planning Scheme.

For your submission to be considered by Council, it must be a 'properly made submission,' which is defined in Schedule 2 of the *Planning Act 2016* as follows:

- √ Full Name/s (of all submitters)
- ✓ Address (where you currently reside or business address)
- ✓ Contact Details (phone number and/or email address)
- ✓ Supporting Information about your submission with details and facts (correct addresses, related images, related reports etc.)
- ✓ If making a hard copy submission, it must be signed and received by Council before 4:30pm on Friday, 6 October 2023.
- ✓ If making an electronic submission it must be submitted before midnight on Friday, 6 October 2023.

Once a submission is made, Council will publish a report on the submissions made and how each of the submissions has been addressed. The report will be published on Council's website.

## How to make a submission

Submissions can be lodged a number of ways:
